GENERAL INFORMATION, TERMS & CONDITIONS

**TERMS OF SALE** By executing a purchase order with The M-Geough Company, Inc. hereto forth AKA M-Geough, the purchaser agrees to the following:

1. The relationship between the purchaser and M-Geough is that of an independent contractor and neither of us nor any of our respective officers, agents or employers will be held or construed to be partners, joint ventures, fiduciaries, employees, or agents of the other.
2. Payment of the balance of the purchase price is due 5 business days from the receipt of the invoice from M-Geough or in some cases the manufacturer. Interest at the rate of 1.5% per week may be charged for all overdue payments.
3. Purchaser agrees to pay all costs of collection including reasonable attorney's fees.
4. This agreement and its performance shall be governed by the laws of the Commonwealth of Massachusetts, without regard to its conflict of law's provisions. The purchaser consents and submits to the exclusive jurisdiction of the state and federal courts located in Suffolk County, Commonwealth of Massachusetts in all questions and controversies arising out of this agreement.

**ORDERING INSTRUCTIONS** M-Geough will provide you with a written request for a 50% deposit for the merchandise you are purchasing from one or more of the manufacturers we represent. Please be sure to check this paperwork carefully to ensure that all the details are correct to avoid any costly errors for you or your client. Once this order is in production you may not be able to make changes. After the deposit is received the order is not subject to cancellation for any reason. If this order is canceled, Buyer shall be liable for Seller's cancellation charges. After we receive your deposit, you will receive an acknowledgment of the order(s) that you should also review and *may* have to sign and return as well.

**CANCELLATIONS AND CHANGES** Each piece is custom made-to-order per the order acknowledgment and its own unique specifications. We may not be able to change or cancel orders that have already been started, usually one week from the date on the order acknowledgment. Your order may be canceled if certain conditions are met, and we determine if the circumstances warrant a cancelation. All cancelations are subject to a **35%** (of the designer net) **restocking fee**.

**LEAD TIMES** Please note the Estimated Completion Date (ECD) on your acknowledgment. This is the day our manufacturer is planning to have your order completed. This is an estimate and not a firm date. M-Geough has no control over that date, and the manufacturer will make every effort to meet this ECD. If for some reason they cannot, we will let you know in advance of the ECD with an updated ECD. The manufacturer may not forward your order to production until receipt of deposit, finish selection and if applicable, a signed drawing for approval (DFA) and/or the finish sample for approval (SFA) is received. Your COM deliveries may impact your ECD.

**SHIPPING** Upon receipt of your balance due, M-Geough will release your order with the manufacturer. M-Geough has no control over the date your order is physically collected by the shipper. M-Geough and/or the manufacturer determine the best shipping company that is contracted to deliver your order to your receiver. Designer reserves the right to decide to have their own shipper collect the order on their behalf prior to the final invoicing process. Designer is responsible for arranging collection and payment to the shipper.

**STORAGE** Manufacturers reserve the right to charge storage fees for any merchandise with an outstanding balance for longer than three weeks after completion.

**FREIGHT DAMAGE CLAIMS** M-Geough is not responsible for damage suffered in transit or in storage. Before accepting merchandise from carrier, you, your consignee, or receiver must examine the shipment carefully. If there is any visible damage to the containers, insist that a notation be made on the Delivery Document before consignee or receiver signs for merchandise. Claims for damage or shortage by delivering carrier should be filed by you, your consignee, or receiver within 48 hours of receipt. When receiving merchandise, which may be "crated, uncrated, or blanket wrapped", the consignee or receiver must unpack and examine merchandise before signing Delivery Document. Note damage, if any, on Delivery Document and keep all crates, boxes and packing materials and file claim with carrier within 48 hours. Claims for merchandise defects or errors must be reported to M-Geough in writing within 48 hours from receipt of merchandise by you, your consignee, or receiver. Failure to do so shall constitute full acceptance of the merchandise.

**SERVICE AND REPAIRS** No return of merchandise will be accepted without prior written authorization. Manufacturer warrants one year for any manufacturing defect under conditions of normal use and reasonable care. This warranty does not cover damage, due to misuse, abuse, or shipping damages.

**COVID 19** Please note delivery limitations and government restrictions regarding COVID-19 can change at a moment's notice. Our shippers remain committed to service, while honoring governmental guidelines and the safety of all involved, in all states. As a result, deliveries may be temporarily delayed.
